	(i) Ellenor Fenn Garden - the opening event was held on 11th September and was very successful. The project has been very well received. It has opened up and improved what was an eyesore in the heart of the town and created a usable and pleasant space. 	(ii) Community Toilets Scheme - Carolyn had incorporated the recommendations written by Mike into the report and has sent the report to Stuart so as to ensure it goes forward to the Social and Welfare Committee meeting on 26 October. Peter said that budget will be needed this year so as to make a start in the current year. Carolyn asked Stuart to deal with this in the meeting since a breakdown of costs has been supplied. 2	Wayfinding - possible launch event

3 Dereham's Town Delivery Plan

DTC held a meeting of all councillors and Emma Crampton on 21 September. This meeting will be minuted.

Overall, the town councillors are happy with the report and approve of the majority of the projects that have been proposed. They have said they look forward to seeing some of the projects start. They also noted some of the inaccuracies which undermine credibility in the report.

Councillors had some questions about the retail environment and what the High Street of the future should aim to be. It was said that a lot of the shops need improvements not only to the frontage but also to the interiors which are not representative of a good, modern retail experience for shoppers. Some of the buildings may be listed which might impose constraints on how buildings can be modified, if at all.

Councillors agreed with the plan's main thrust to attract higher value businesses which in turn employ higher skilled people on higher wages, but asked how this can be achieved. It was agreed that a start should be made towards this goal, however small.

Breckland Council are producing a skills report. This can be helpful when prioritising actions from the delivery plan. There seems to have been, as far as we are aware, a lack of involvement of the schools in the development of the delivery plan. There seems to be a lack of joined-up thinking around future skills needs.

We were told the report indicates around £11m to refurbish the Breckland Business Centre - but before spending the money they need to ensure there will be sufficient demand.

DTC agree with aD's point that there needs to be a group to oversee progress on the plan which will evolve as time goes on and said that it needs to be a joint approach by all three councils, with the ability to bring in other stakeholders. We spoke about the lack of a Chamber of Commerce and thought that perhaps a suitable representative could from the business banking sector, or the accountants in Dereham since they know the views of business.

Carolyn spoke about the 'quick win' idea of a year-round events programme. She said the voluntary & community sector does not have the capacity to organise this and there needs to be a professional events organiser with a budget for a varied programme of events.

Peter asked if the minutes of the DTC meeting can be shared and Stuart said he will check this.

Both Philip and Phillip pointed out this is a long term process and the plan will change - but we all need to support it now if we hope to attract funding for some of the schemes.

	It was also said that Dereham does not have a USP and does not fit any of county's priorities (i.e. not a windfarm etc). Peter asked if he can submit comments for us to include in the aD draft response.
